### **PARKING POLICIES**

I agree to comply with the Beede Center/Town's membership policies and rules, which may be communicated to me in writing, through club signage, or verbally. The Beede Center/Town, at its sole discretion, reserves the right to modify the Student Parking Agreement without prior notice. The Beede Center/Town also reserves the right to terminate this agreement and revoke the parking pass immediately for violation of any policy or rule, with no refunds.

### DISCLAIMER

The parking spot reserved at the Beede Swim & Fitness Center is exclusively available for students in the Junior Class of Concord-Carlisle High School selected through a lottery system for the 2025-2026 school year. The reservation applies only from **7:00 AM to 4:00 PM**, Monday through Friday, and is strictly limited to the 2025-2026 school year. Outside these designated hours—including evenings, weekends, school holidays, and summer break—the Beede Swim & Fitness Center retains the right to use this parking spot as needed. **Passes are non-transferable**; any student found sharing, selling, or transferring their pass will have it revoked immediately, with no refund issued.

By accepting this lottery spot, you acknowledge and accept these conditions. Securing a spot requires payment of a \$300.00 fee and adherence to all guidelines and responsibilities. The parking tag must be hung from the rear-view mirror with the parking number always facing out and visible. **Failure to comply with any of these requirements may result in the forfeiture of your parking spot.** 

### **RELEASE OF LIABILITY AND ASSUMPTION OF RISK**

I understand and expressly agree that my use of the Beede Swim & Fitness Center (hereafter referred to as "Beede Center"), acting through the Town of Concord (hereafter referred to as "Town"), involves the risk of injury to myself or my guest(s), whether caused by my actions or otherwise. I understand that these risks range from minor injuries to severe injuries, including death.

In consideration of my participation use of the Beede Center's facilities, I voluntarily accept this risk and agree that neither the Beede Center nor the Town, including its staff, directors, members, agents, or independent contractors, will be liable for any injury, whether personal, bodily, or mental, or for economic loss or damages to myself, my spouse, domestic partner, guests, child, unborn child, or relatives, resulting from the negligence of the Beede Center/Town or any individual acting on its behalf, whether related to the parking lot or otherwise. Accordingly, I hereby forever release and discharge the Beede Center/Town from any and all claims, demands, injuries, damages, actions, or causes of action.
